Form 990, Part III, Line 4a - Program Service Accomplishments

In 2012, Heaven on Earth purchased its own property in North Hollywood and built out Perry's Place, named in memory of Seth and Rachael MacFarlane's mother. This 5,500 square foot state-of-the-art no-kill sanctuary and adoption Center enabled us to double the size of our former rented space and our capacity to pull cats from municipal shelters, care for them during their quarantine period, and ultimately, place most in homes. For those who are not adopted, mainly due to age, chronic health issues, or special needs, Perry's Place is their forever home.

We have expanded our lifesaving impact since dedicating Perry's Place in 2013, increasing adoptions from 52 in 2011 to 621 in 2018, intakes from 132 to 862, and spay/neuters to 1,001 last year. In total, we touched the lives of more than 2,000 cats (and an estimated 10,000 people) in 2018.

A major milestone in late 2018 was beginning a foster program, to provide temporary housing and extra socialization for kittens and cats. This will help us maintain a healthy capacity for care at Perry's Place, where more than 1,100 cats and kittens enjoyed safe haven at some time during 2018. This included the 560 underage kittens we rescued from the city shelters and cared for until they reached 2 pounds and could be spayed or neutered. Subsequently, most were adopted, along with many adult cats. Looking ahead to 2019, we plan to fully implement the foster program, providing temporary care for 300 kittens and adult. This will enable us to take in at least 700 kittens during the peak of this year's kitten season.

Also in 2019 we will fully ramp up operation of our new Heaven on Earth Animal Clinic, located within the West Valley City Shelter in Chatsworth. In addition to providing a full array of affordable veterinary services to dogs, cats and rabbits, the clinic is designated high volume spay and neuter clinic, whose ultimate goal is to sterilize 6,000 animals annually.
